#4322 An Ordinance to Amend Chapter 2 of the City Code in Order to Authorize the City Treasurer Access to the Budget Reserve Account Funds at the End of a Fiscal Year and Replenishment of the Budget Reserve Account Funds in the Ensuing Fiscal Year for Fiscal Year 2017 **(1<sup>st</sup> & 2<sup>nd</sup> Reading)**

**Synopsis:** *This Ordinance is being presented by the City Treasurer for Council's review and approval. If approved, Council would be amending Chapter 2 §2-379(c) of the City Code to update and codify provisions related to the budget reserve account funds. The Ordinance would authorize the City Treasurer to access budget reserve account funds, extend the period from July 1, 2016 to June 30, 2017, and require that funds be replenish no later than October 1, 2017.*

#4323 An Ordinance to Authorize the Annual Reconciliation of Accounts by Transferring Funds to Various Offices and Departments in the City of Wilmington to Fulfill Obligations for the Remainder of Fiscal Year 2016 **(1<sup>st</sup> & 2<sup>nd</sup> Reading)**

**Synopsis:** *This Ordinance is being presented by the Administration for City Council's review and approval. If approved, the Council would be authorizing reconciliation of budget accounts for the previous fiscal year ending June 30, 2016.*
