This Ordinance amends Chapter 4 of the City Code by repealing Subchapter 7 in its entirety, which eliminates (1) licensing requirements for stationary engineers and firemen operating steam boilers, turbines, and engines in the City; (2) attendant and inspection requirements for power boilers, fired pressure vessels and installations using nuclear fuel; and (3) the Board of Examining Engineers.*
