#0218 An Ordinance to Amend Chapter 14 of the City Code Pertaining to Historic

Markers (1st & 2nd Reading)

**Synopsis:** This Ordinance is being presented by City Council for City Council's review and

approval. This Ordinance updates the City's Historic Marker Program, including the creation of a City Council Subcommittee to determine the location of historic markers, and the creation of a taskforce to determine the types of markers to be installed, which materials will be used for the markers, and to ensure that the City's historic markers do not duplicate state historical markers in visual

appearance.

#0219 An Ordinance to Amend Chapter 37 of the City Code to Extend the Fire Lane

Along the Entire Extension of Christina Landing Drive (1st & 2nd Reading)

**Synopsis:** This Ordinance is being presented by City Council for Council's review and

approval. This Ordinance amends Chapter 37 of the City Code to allow for the fire lane to be extended through the entire extension of Christiana Landing Drive

to prevent unlawful parking.

**Synopsis:** This Ordinance is being presented by the Administration for Council's review and

approval. This Ordinance rezones three parcels of land located at the southeast corner of Fourth and Shipley Streets (being Tax Parcel Nos. 26-043.10-188, 26-043.10-189, and 26-043.10-190), which are commonly known as "Humble Park", from a zoning classification of O (Open Space) to a zoning classification of C-3

(Central Retail).

#0206 A Resolution Approving the Bid of the Best Bidder for the Disposition of Three

Parcels of Land Commonly Known as "Humble Park"

Synopsis: This Resolution is being presented by the Administration for Council's review and

approval. This Resolution approves the bid of The Buccini/Pollin Group, Inc. for three parcels of real estate located at the southeast corner of Fourth and Shipley Streets, Wilmington, Delaware 19801 (being New Castle County Tax Parcel Nos. 26-043.10-188, 26-043.10-189, and 26-043.10-190), which are commonly known as "Humble Park", as the best bidder and authorizes the Mayor and the City Clerk, or their respective designees, to execute any and all documents necessary

to effectuate the disposition of such properties to The Buccini/Pollin Group, Inc.

#0220 An Ordinance to Amend Chapter 2 of the City Code to Clarify the Funding of and

Appropriations from the Budget Reserve Account, the Tax Stabilization Reserve, the Water/Sewer Fund Operation and Maintenance Reserve, and the Water/Sewer

Fund Rate Stabilization Reserve (1st & 2nd Reading)

**Synopsis:** This Ordinance is being presented by the Administration for Council's review and

approval. This Ordinance amends Divisions 2, 3, and 4 of Article VI of Chapter 2 of the City Code to clarify the funding and appropriations provisions of the budget reserve account, the tax stabilization reserve, the water/sewer fund

operation maintenance reserve, and the water/sewer fund rate stabilization

reserve regarding (i) their respective calculation, (ii) the respective order of their funding, and (iii) the meaning of the term "appropriations" with respect to the aforementioned reserves. It also provides for certain housekeeping matters for consistency, clarity, and conciseness.
